Midlands Columbia Youth Football Organization 2010 Parent Contract

I have been advised of the player/cheerleader eligibility requirements for Pop Warner and for Midlands Columbia Youth Football Organization (MCYFO). I understand I must submit all required documentation and registration fees in full for my child to be placed on a roster. Required documentation is as follows: (a) 2010 Pop Warner Physical Fitness and Medical History Form, (b) 2010 Pop Warner Participant Contract and Parental Consent Form, (c) MCYFO Parent Contract, (c) \$150 registration fee for football and/or \$125 registration fee for spirit/cheer, (e) copy of my child's birth certificate and (f) copy of my child's 2009-2010 report card. All fees and forms must be received no later than June 1, 2010. **I understand my child will not be eligible to participate at MCYFO until all necessary items have been submitted.** _____

Proof of satisfactory progress in school is required. A 2.0/70% or the equivalent shall be the minimum grade point average acceptable to participate. If my child does not meet the requirements of scholastic eligibility, I may fill out and submit a Scholastic Eligibility Form. The Scholastic Eligibility Form must be accompanied by a satisfactory progress report or report card to be eligible for participation after the October 2010 deadline. That report must be dated between September 3, 2010 and October 1, 2010. If no passing progress report or report card is given in this window, then my child shall be found ineligible for the rest of the year. **I understand and agree with the scholastics regulations.** _____

I have been advised of the MCYFO refund policy. I will receive a full refund of any amount paid on or before June 30, 2010, minus \$5 (the administrative registration fee). I will receive a refund of registration minus \$50 of any amount paid from July 1 – August 1, 2010 (the total amount for the participation t-shirt, insurance/league fees, and administrative registration fee). **After August 1, 2010, no more refunds will be issued (unless accompanied by a medical excuse). I understand I will not be eligible for a refund after August 1, 2010.** _____

I have been advised of the MCYFO financial responsibilities regarding fundraising. I will be responsible for participating in mandatory fundraisers this season. If I choose not to participate in the fundraisers, I may elect to do a buy-out of \$50. If I elect not to do either, my child will not be able to participate in any post-season activities. **I agree to comply with the fundraising obligations for MCYFO.** _____

I have been advised that it is my duty to insure my child is present at all scheduled practices during the week and that I will remain at the practice location with my child. If the time arises that I must leave the field I am required at minimum to notify the Team Mom and give a specific time of my return. I understand that if my child misses 2 practices in any given week, that he will not be eligible to play in that weekend's game. The uniform for the suspended game will be jersey only without any equipment. **I agree to comply with attendance obligations for MCYFO.** _____
